They are tasked to assist the Division Management in the implementation of Sports Development Programs and Activities including para sports such as: a) Teacher Sports Training, b) Talent identification/recruitment of potential athletes, c) Organization of District/Division level sports club, d) Implementation and advocacy of Grassroots Sports Programs, Projects and Activities, e) Networking and fund sourcing, f) Benchmarking best practices, g) Managing and Officiating Sports Competitions, and h) All other sports related activities as maybe authorized by law.
- 4. This designation takes effect immediately and terminated/renewed after one year if needed.
- 5. Sports activities should abide by the DepEd policy on NO DISRUPTION OF CLASSES.
- 6. Must comply with the existing local ordinances and health protocols in the area.
- 7. Adherence to this memo is highly urged.
