- 1. As Department of Education continue to confront the issues brought about by the pandemic, we in the Schools Division of Benguet are doing our part in addressing challenges in the basic education through our localized Learning Continuity Plan (LCP). It is reiterated in the LCP that in order to contribute to quality programs, projects, and activities in the improvement of the Curriculum Development for improved delivery and instruction, and assessment specifically in ensuring efficient implementation of the MELCS across grade levels and learning areas, master teachers are to be up skilled in writing and implementing researches in their assigned work stations.
- 2. The School Governance and Operations Division thru the Planning and Research Section will conduct a four day research up skilling for all Master Teachers in the 14 districts and to include identified teachers I to 3 of Kibungan, Kabayan and Kapangan on June 24 and 25, 2020 (Batch 1) and July 1 and 2, 2020 (Batch 2) through webinar.

  - Batch 2 Mankayan, La Trinidad, Tublay, Sablan, Atok, Bakun, Bokod
- 3. Participants to the webinar must confirm their attendance on or before 6pm of June 23, 2020 (Batch 1) and June 30, 2020 (Batch 2) by texting this number: 09187432221. Master Teachers who are members of the Research Technical Working Group and those with approved research proposals for CY 2020 or SY 2020-2021 are excluded from this webinar.
- 4. Panel defense for all researchers with submitted research proposals and completion reports through online conference will continuously be implemented and scheduled anytime following the convenience and availability of internet connection of both panel members and researchers.

- 5. Participants are expected to prepare their laptop with browser or mobile phone installed with hangouts Meet application. Google meet link for both webinar and panel defense will be texted or emailed to the participants contact details or email addresses.
- 6. A cell card load amounting to 300Php will be issued to participants for use during the webinar, while 100 Php card load will be issued to all researchers and panel members in the conduct of the online panel defense chargeable against 2020 HRTD fund subject to the usual auditing rules and regulations.
