



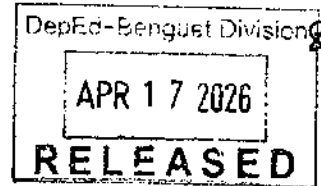

RE-COMPOSITION OF THE DIVISION REVIEW AND EVALUATION COMMITTEE (DREC) RELATIVE TO THE APPLICATION OF PUBLIC AND PRIVATE SCHOOL REGULATORY SERVICES

1. This Office issues this Memorandum relative to the **re-composition of the Division Review and Evaluation Committee (DREC)** responsible for the evaluation of applications under Public and Private School Regulatory Services.

2. The regulatory services for **public schools** shall cover, but are not limited to, applications for *Establishment, Merging, Conversion, and Naming/ Renaming of Public Schools and Separation of Public School Annexes in Basic Education*; and *Implementation of the Senior High School (SHS) Program*, which include the establishment of stand-alone public SHSs and the conversion of existing public elementary and junior high schools into stand-alone SHSs. Meanwhile, regulatory services for **private schools** shall include applications for Government Recognition and Permit, additional Senior High School programs, increase or change of tuition and other school fees, issuance of Special Orders, and other related concerns.
