SUBJECT: Division Webinar- write shop of Elementary MAPEH Teachers on the Development of Modules for Grades 1-6 and grades 7-12, Q3 and Q4.

- 1. Pursuant to DepEd's Sulong Edukalidad and its battle cry on the continuous delivery of quality basic education and in support to Regional Memorandum No. 090 s. 2020 re: Development of Learning Resources and Survey on Alternative Learning Delivery Modes, the Schools Division of Benguet plan for contingency measures relative to the implementation of Basic Education-Learning Continuity (BE-LC) Plan should the quarantine period be extended until the first quarter of the next school year.
- 2. In connection, SDO Curriculum Implementation Divisions, through the Learning Resource Management Sections facilitated the development of learning resources for Q1 and Q2.
- 3. In anticipation to the implementation of distance learning until the last quarter of the school year 2020-2021, a webinar-workshop on the development of MAPEH Module for Quarter 3 and 4 shall be conducted. The learning resources shall be K to 12 MELC-Based modular type, which may be delivered through modular distance learning on an offline mode.
- 4. Objectives of the Training-workshop

The participants shall have:

- a. participated actively in the webinar/online and offline training-workshop.
- b. equipped with the knowledge and skills in developing a user-friendly modular type learning resources as Alternative Delivery Modes are appropriate for online/offline teaching-learning.
- c. developed a Quarter 3 and Quarter 4 MELC-based module outputs in MAPEH Components.
- 5. The Webinar-workshop shall be done in 3 online sessions on different days as follows:

November 17, 2020	Secondary	Presentation and Critiquing of Outputs

After each online session, shall be a hands-on workshop in module development, improvement / revisions, enhancement/finalization/packaging and submission respectively. An Online/Offline platforms/media such as Messenger Chats, Mobile phone calls, text messaging and emails shall be utilized in all communications and transactions among the participants, partners, coaches and monitoring for technical assistance along the processes of the module development. Email adds and sourcing out/downloading and uploading needed materials (digital/audio-videos, prints, pictures/illustrations, etc.) are likewise necessary in the module development.

- 6. Module developers/participants to the training-workshop are the identified MAPEH teachers from the different schools of SDO-Benguet, elementary and secondary. Lists to be attached.
- Participants are reminded to the whole day webinar/online in all the scheduled 3 sessions.
 Service Credits shall be granted to each teacher developer, based on module output submitted.
- 8. Internet /WIFI load will be provided each participant to use during the first 3 sessions online and during offline chats, calls, and text messaging while on hands-on write shops. The cell card loads shall be chargeable against 2020 SDO-HRTD fund subject to the usual accounting and auditing rules and regulations.
