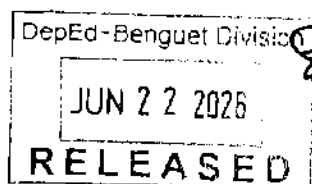

**SUBMISSION AND UPLOADING OF SCHOOL SELF-APPRAISAL CHECKLISTS
(SACs) AND MEANS OF VERIFICATION (MOVs) FOR THE 2026 HEALTHY
LEARNING INSTITUTIONS (HLI) CERTIFICATION**

1. In relation to the DOH-CHD-CAR Advisory regarding the *"Prescribed Deadlines for the Submission of List of Target Schools and Initially Validated Self-Appraisal Checklist (SAC) and Means of Verifications (MOVs) per Quarter for the Implementation of the Healthy Learning Institutions (HLI) Program for Calendar Year 2025-2026,"* and as agreed upon during the HLI Review and Workshop held last May 20 and 21, 2026, this Office directs the identified 2nd Quarter Target Schools to submit and upload their respective SACs and MOVs.

3. Additionally, **Ampuntoc Elementary School** is directed to upload their **Pillar 4 MOVs ONLY**.
