

Program Implementation Review and Capacity Building of Implementers of the Madrasah Education Program (MEP)

To: Chief Education Program Supervisors for CID and SGOD Education Program Supervisors Public Schools District Supervisors and Public Schools District In-charge All Others Concerned

- 1. Relative to DO 41 s. 2011, titled "Guidelines on Madrasah Education in the K to 12 Basic Education Program " and the MATATAG Agenda particularly in Take good care of the learners by promoting learners well-being, inclusive education and a positive learning environment and Give support to teachers to teach better, the Schools Division of Benguet, through the Curriculum Implementation Division (CID) is conducting a training for school personnel implementing Madrasah Education Program (MEP) in the division and program implementation review of MEP for SY 2023-2024 on July 24-26, 2024, at ATI-CAR, BSU Compound, La Trinidad, Benguet.
- 2. The activity aims to strengthen the implementation of MEP by:
 - a. gathering valuable information from the stakeholders on the implementation of MEP;
 - b. orienting the participants on the related issuances on MEP;
 - c. developing locally prepared learning resources for MEP and
 - d. Increasing collaboration between and among school personnel implementing MEP.
- 3. Lunch and snacks shall be charged against the 2024 Program Support Fund for MEP downloaded to the division office while transportation and other expenses will be charged against local funds subject to the usual accounting and auditing rules and regulations.
- 4. Participants in this activity are identified in enclosure 1 of this memorandum. The teacher- participants shall be granted three -day service credits since this activity falls on the end- of -school year break (EOSY). This is in accordance with DO 53, s. 2003 titled Updated Guidelines on Grant of Vacation Service Credit to Teachers.
