## 2. The Conference Aims to:

- a. Submit the final skills per district per level to be contested;
- b. Review the contest Package per area;
- c. Prepare functional and workable scoring rubrics, summary sheet and other documents based on the skills package provided during the conduct of the activity.
- d. Submit initial papers/documents of coaches and contestants:

#### d.1. Contestants

- Certification by the head that the participant/s is/are bonafide student/s enrolled in public / private elementary, general secondary or Technical-Vocational School during the school year 2015-2016.
- Certification of the school head that the students are enrolled in the field of specialization where they are competing and participating,
- Photocopied School I.D.
- Form 137 with 2 x 2 picture attached, and

#### d.2. Coaches

- Certification from the Principal that the teacher is a bonafide staff of the school being represented,
- Certification from the Principal of the Teacher's designation as the adviser / coach of the student participant,
- Service record, and
- Photocopied School I.D.

d.3. The requirements shall be placed in a short brown envelope on the upper right hand part of the envelope (the side without the flap) write the name of the School, district, and /or University indicated, name of contestant/s and name of the coach.
